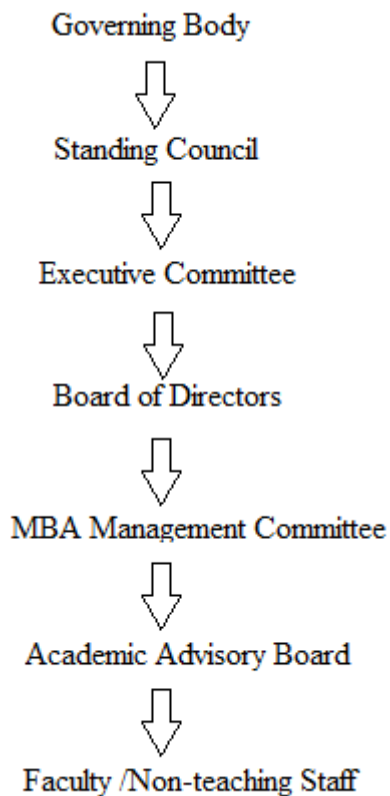

The student participation in the academic affairs and improvement process is ensured by forming the MBA Association with committees for all activities, curricular and co-curricular. 'Open House' program is conducted where the faculty, parents and students sit together to discuss the various aspects related to improving the academic and overall development of the student and suggest improvements.

The College provides the students with an intense and stimulating learning environment relevant to current business scenario. In addition to the regular course work, the Department conducts seminars, workshops, personality development courses etc. for the students. The Department lays great stress on discipline, punctuality and commitment, which are the vital values necessary for long-term development of a successful individual.

In addition to this students undergo a short term project (organization study) and a major project as stipulated by the university. Most students undergo an internship along with this for better industry interaction and for acquiring practical knowledge.

• **Grievance Redressal mechanism for Faculty, staff and students**

The Management Committee looks into the grievances of the faculty and other staff and if required it is forwarded to the Governing Board/Standing Council.

The department has a grievance redressal committee to handle the grievances of the students and try to take necessary steps if required. If a solution is not found it is forwarded to the coordinators and the management committee.

Admission to MBA Degree programme shall be on the basis of merit as determined by marks secured at the graduate /post graduate level, scores obtained in the Management admission eligibility test like IIM-CAT/ CMAT/KMAT-Kerala, Group Discussion and Interview.

Only CAT, CMAT and KMAT are accepted for admission to MBA course in Kerala. The minimum Qualifying Cut off marks is 15% for General Category and 10% for SEBC and 7.5% for SC/ST.

A pass in any Bachelor's Degree Examination of Mahatma Gandhi University or an equivalent degree of any other Universities duly recognized by Mahatma Gandhi University with not less than 50% marks in the aggregate for all parts of examination or a Master's Degree examination with 50% marks in aggregate. Under grading system, C Grade of Mahatma Gandhi University or equivalent thereto from other recognized Universities with not less than 50% marks in aggregate is required to become eligible for admission. Under any circumstances, it shall be the responsibility of the Director / Principal to ensure that a candidate is having 50% marks in aggregate in order to become eligible for admission. A pass in any Bachelor's Degree examination is needed for SC/ST candidates. The Reservation Rules are applicable as per the Government and University norms in all the affiliated Colleges.

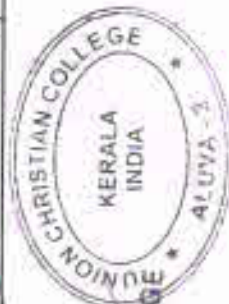
